**Elder abuse** is any act which causes harm to an older person and is carried out by someone they know and trust such as family or friends.

#### **Emotional Abuse**

Using threats, humiliation or harassment to cause anguish and feelings of shame or powerlessness. Preventing contact with relatives, friends or service providers or restricting activities.

#### Physical Abuse/Sexual Abuse

Inflicting pain or injury such as hitting, slapping, pushing, inappropriate use of restraints or medications and/or any sexual activity for which the person has not consented.

#### Financial Abuse

Using someone's money, property or other assets illegally or improperly, misuse of power of attorney or forcing someone to change their will or sign documents.

#### Neglect

Failing to provide the basic necessities of life; (ie. food, shelter, medication) either intentionally or unintentionally.



## What Are the Signs?

Older adults who are experiencing abuse or neglect may:

- Tell you they are being harmed
- Seem fearful around certain people
- Become socially withdrawn
- Become passive and compliant
- Have unexplained physical injuries
- Lack food, clothing or other necessities
- Show changes in their hygiene or nutrition
- Suddenly become unable to meet financial obligations
- Have unusual withdrawals from their bank or other financial institutions



## Rights

Older people have the right to:

- Live in safety
- Be treated with dignity and respect
- Make their own choices, even if they seem wrong to others

Elder abuse is when these rights are denied, resulting in harm.

Elder Abuse is a Crime!
